WHEREAS, Hospital Service District No. 2 of the Parish of Beauregard, State of Louisiana (the "Issuer"), by resolution adopted on July 9, 2018, proposes to issue not exceeding \$1,204,450 of Certificates of Indebtedness (the "Certificates") for the purpose of providing funds for acquiring, constructing, and installing improvements and replacements to the hospital facilities of the Issuer, including acquiring equipment and fixtures therefor (the "Project"), and paying costs of issuance of the Certificates. The Certificates will be issued under the authority of Sections 2921 to 2925, inclusive, of Title 33 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority.

WHEREAS, it is now the desire of the Police Jury of the Parish of Beauregard, State of Louisiana, to approve the issuance of the Certificates;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Beauregard, State of Louisiana, acting as the governing authority of Hospital Service District No. 2 of the Parish of Beauregard, State of Louisiana, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of the Issuer, this Police Jury hereby approves the issuance and sale of not exceeding \$1,204,450 of Certificates of Indebtedness, said Certificates to be issued under the authority and for the purposes stated in the preamble hereto.

SECTION 2. Neither the Parish nor this Police Jury shall be liable in any manner for the payment of the Certificates.
