

## **PUBLIC NOTICE**

Notice is hereby given that a Public Hearing will be held on Thursday, November 17, 2022, at 5:00 p.m. by the Beauregard Parish Police Jury at its Administration Building, 201 W. 2<sup>nd</sup> Street, DeRidder, Louisiana, 70634, to adopt Ordinance 02-2022 to establish divided precincts, provide for polling locations and to adopt a redistricting plan for the Beauregard Parish Police Jury. ## **ORDINANCE NO: 02-2022**

An Ordinance to amend and replace Ordinance No. 01-2011, Municode Section 17-21, and Ordinance No. 01-2017 to establish divided precincts, provide for polling locations and to adopt a redistricting plan for the Beauregard Parish Police Jury; and otherwise, to provide with respect thereto.

WHEREAS, the Beauregard Parish Police Jury is elected from single-member districts;

WHEREAS, interposing the population data from the 2020 federal decennial census into the current districting plan for the Beauregard Parish Police Jury discloses that there are districts which exceed the acceptable population deviation under the principal of one-person-one-vote;

WHEREAS, Louisiana law requires the Beauregard Parish Police Jury to declare whether its existing districting plan is malapportioned following a federal decennial census; and if so, provide for a new redistricting plan;

WHEREAS, the Beauregard Parish Police Jury, is unable to create a redistricting plan using the whole precincts submitted to the United States Bureau of the Census and, in accordance with LRS 18:532.1(D)(2), will need to divide several precincts into two or more precincts, which divisions shall be by a visible feature which are census tabulation boundaries.

NOW, THEREFORE, BE IT ORDAINED BY THE BEAUREGARD PARISH POLICE JURY THAT:

### **SECTION 1**

A. The Beauregard Parish Police Jury hereby divides and creates new precincts to be used in its redistricting plan to be first implemented for all purposes related to the qualifying for elections and the regularly scheduled elections for Beauregard Parish in the Fall of 2023.

B. The geographic precinct divisions are described below and more specifically depicted and clarified in the maps, electronic shapefiles and block equivalency files submitted to the Louisiana Secretary of State and the Beauregard Parish Registrar of Voters for their implementation.

C. The Precincts listed in Part C are described specifically in Part D

Precinct 1 hereby divided to create Precincts 1 and 1A

Precinct 7 is hereby divided to create Precincts 7, 7A, 7B and 7C

Precinct 11 is hereby divided to create Precincts 11, 11A and 11B

Precinct 12 is hereby divided to create Precincts 12 and 12C

Precinct 16 is hereby divided to create Precincts 16 and 16D

Precinct 16B is hereby divided to create Precincts 16B and 16C

Precinct 26 is hereby divided to create Precincts 26 and 26A

Precinct 27 is hereby divided to create Precincts 27 and 27C

Precinct 28 is hereby divided to create Precincts 28 and 28A

**D1. Precinct 1 hereby divided to create Precincts 1 and 1A**

*Polling Location: Precincts 1 and 1A shall have a consolidated polling location at the current polling location of Precinct 1.*

**Precinct 1**

Shall be the prior Precinct 1, less and except Precinct 1A as herein described.

**Precinct 1A**

Beginning at the intersection of Beauregard Parish boundary and State Route 109, thence north and northeast on State Route 109 to its intersection with Hwy 389, thence east and south on Hwy 389 to its intersection with Beauregard Parish boundary, thence west on the Beauregard Parish boundary to its intersection with the point of beginning

**D2. Precinct 7 is hereby divided to create Precincts 7, 7A, 7B and 7C**

*Polling Location: Precincts 7, 7A, 7B and 7C shall have a consolidated polling location at the current polling location of Precinct 7.*

**Precinct 7**

Shall be the prior Precinct 7, less and except Precincts 7A, 7B and 7C as herein described.

**Precinct 7A**

Beginning at the intersection of Beauregard Parish boundary and a unnamed road near (-93.386841, 30.882642), thence south, east and south on the unnamed road to its intersection with unnamed railway, thence west and south on the railway to its intersection with Hwy 190 W, thence east on Hwy 190 W to its intersection with State Route 3226, thence north on SR 3226 to its intersection with Beauregard Parish boundary, thence west on the Beauregard Parish boundary to its intersection with the point of beginning

**Precinct 7B**

Beginning at the intersection of Hwy 190 W and an unnamed railway near (-93.386648, 30.239206), thence south on the railway to its intersection with Graybow Rd, thence east on Graybow Rd to its intersection with unnamed stream 259 feet northeast of Ward Line Rd, thence south on the stream to its intersection with Cowpen Creek, thence northerly on the creek to its intersection with Pine Ridge Rd, thence north on Pine Ridge Rd to its intersection with Graybow Rd, thence northeast on Graybow Rd to its intersection with State Route 3099, thence north on SR 3099 to its intersection with Blankenship Rd, thence west on Blankenship Rd to its intersection with Hwy 190 W, thence northeast on Hwy 190 W to its intersection with

Planer Mill Rd, thence north on Planer Mill Rd to its intersection with Massey Rd, thence west on Massey Rd to its intersection with Wingate Rd, thence north on Wingate Rd to its intersection with Glendale Rd, thence west on Glendale Rd to its intersection with State Route 3225, thence south on SR 3226 to its intersection with Hwy 190 W, thence west on Hwy 190 W to its intersection with the point of beginning

#### **Precinct 7C**

Beginning at the intersection of Pujo Rd and Graybow Rd, thence east on Graybow Rd to its intersection with unnamed stream 259 feet northeast of Ward Line Rd, thence south on the stream to its intersection with Cowpen Creek, thence south on the creek to its intersection with State Route 27, thence west on SR 27 to its intersection with Otto Franklin Rd (Parish Rd 457) , thence north on PR 457 to its intersection with Neale Oilfield Rd, thence west on Neale Oilfield Rd to its intersection with Pujo Rd, thence north on Pujo Rd to its intersection with to the point of beginning

### **D3. Precinct 11 is hereby divided to create Precincts 11, 11A and 11B**

*Polling Location: Precincts 11, 11A and 11B shall have a consolidated polling location at the current polling location of Precinct 11.*

#### **Precinct 11**

Shall be the prior Precinct 11, less and except Precincts 11A and 11B as herein described.

#### **Precinct 11A**

Beginning at the intersection of Clark Rd and State Route 12, thence northeast on SR 12 to its intersection with Hickory Branch, thence north on Hickory Branch to its intersection with Cole Creek, thence north and northwest on the creek to its intersection with Dru Rd, thence south on Dru Rd to its intersection with Susie Alston Rd, thence west on Susie Alston Rd to its intersection with Clark Rd, thence south on Clark Rd to its intersection with the point of beginning

#### **Precinct 11B**

Beginning at the intersection of Beauregard Parish boundary and Camp Edgewood Rd, thence southeast on Camp Edgewood Rd to its intersection with Pilgrim Rest Rd, thence north on Pilgrim Rest Rd to its intersection with Missouri Pacific Railway, thence northeast on the railway to its intersection with Cowpen Creek, thence north on the creek to its intersection with State Route 12, thence northeast on SR 12 to its intersection with Hickory Branch, thence south on Hickory Branch to its intersection with Beauregard Parish boundary, thence west and north on the boundary to its intersection with the point of beginning

**D4. Precinct 12 is hereby divided to create Precincts 12 and 12C**

*Polling Location: Precincts 12 and 12C shall have a consolidated polling location at the current polling location of Precinct 12.*

**Precinct 12**

Shall be the prior Precinct 12, less and except Precincts 12C as herein described.

**Precinct 12C**

Beginning at the intersection of US Hwy 190 and Newt Hodges Rd, thence south on Newt Hodges Rd to its intersection with Foreman Rd, thence east and south on Foreman Rd to its intersection with Fawn Trail, thence east on Fawn Trail for .467 miles to its intersection with a branch of Boggy Creek, thence northeast on the branch to its intersection with Boggy Creek, thence east and southeast on the creek to its intersection with the Beauregard Parish boundary, thence north on the boundary to its intersection with US Hwy 190, thence west on US Hwy 190 to its intersection with the point of beginning

**D5. Precinct 16 is hereby divided to create Precincts 16 and 16D**

*Polling Location: Precincts 16 and 16D shall have a consolidated polling location at the current polling location of Precinct 16.*

**Precinct 16**

Shall be the prior Precinct 16, less and except Precincts 16D as herein described.

**Precinct 16D**

Beginning at the intersection of State Route 26 and Townsley Rd, thence south on Townsley Rd to its intersection with Scallon Rd, thence west on Scallon Rd to its intersection with Crow Pen Branch, thence southeast on the branch to its intersection with Bundick Creek, thence southeast and northeast on Bundick Creek to its intersection with Deer Creek, thence northerly on Deer Creek to its intersection with State Route 26, thence west on SR 26 to its intersection with the point of beginning

**D6. Precinct 16B is hereby divided to create Precincts 16B and 16C**

*Polling Location: Precincts 16B and 16C shall have a consolidated polling location at the current polling location of Precinct 16B.*

**Precinct 16B**

Shall be the prior Precinct 16B, less and except Precincts 16C as herein described.

**Precinct 16C**

Beginning at the intersection of Ball Rd and Barnes Creek, thence southeast on the creek to its intersection with Granger Rd, thence south on Granger Rd to its intersection with South Mennonite Rd, thence east and north on South Mennonite Rd to its intersection with Mennonite Rd, thence east on Mennonite Rd to its intersection with US Hwy 171, thence north on US Hwy 171 to its intersection with Ball Rd, thence west on Ball Rd to its intersection with the point of beginning

**D7. Precinct 26 is hereby divided to create Precincts 26 and 26A**

*Polling Location: Precincts 26 and 26A shall have a consolidated polling location at the current polling location of Precinct 26.*

**Precinct 26**

Shall be the prior Precinct 26, less and except Precincts 26A as herein described.

**Precinct 26A**

Beginning at the intersection of W North St and N Pine St, thence south on N Pine St to its intersection with W 1<sup>st</sup> St, thence east on W 1<sup>st</sup> St to its intersection with N Stewart St, thence north and east on N Stewart St to its intersection with Carlisle St, thence north on Carlisle St to its intersection with W North St, thence west on W North St to its intersection with the point of beginning

**D8. Precinct 27 is hereby divided to create Precincts 27 and 27C**

*Polling Location: Precincts 27 and 27C shall have a consolidated polling location at the current polling location of Precinct 27.*

**Precinct 27**

Shall be the prior Precinct 27, less and except Precincts 27C as herein described.

**Precinct 27C**

Beginning at the intersection of W 1<sup>st</sup> St and S Division St, thence south on S Division St to its intersection with W 5<sup>th</sup> St, thence west on W 5<sup>th</sup> St to its intersection with S Texas St, thence south on S Texas St to its intersection with Graybow Rd, thence southwest on Graybow Rd to its intersection with Loftin Rd, thence south on Loftin Rd for 130 feet to its intersection with an unnamed railway, thence northeast on the railway for 1.74 miles to its intersection with unnamed railway, thence northwest on the railway for 183 feet to its intersection with an extension of Mayeaux Dr, thence west on the extension and Mayeaux Dr to its intersection with a railway 136 feet east of S Washington St, thence north on the railway to its intersection with W 1<sup>st</sup> St, thence west on W 1<sup>st</sup> St to its intersection with the point of beginning

**D9. Precinct 28 is hereby divided to create Precincts 28 and 28A**

*Polling Location: Precincts 28 and 28A shall have a consolidated polling location at the current polling location of Precinct 28.*

**Precinct 28**

Shall be the prior Precinct 28, less and except Precincts 28A as herein described.

**Precinct 28A**

Beginning at the intersection of a railway 136 feet east of S Washington St and E 4<sup>th</sup> St, thence east on E 4<sup>th</sup> St for 0.2 mile to its intersection with and unnamed railway, thence southeast on the railway for 0.395 miles to its intersection with an extension of Mayeaux Dr, thence west on the extension and Mayeaux Dr to its intersection with a railway 136 feet east of S Washington St, thence north on the railway to its intersection with the point of beginning

## **SECTION 2**

A. The redistricting plan entitled **Beauregard Parish Police Jury – Plan 2022**, as described below and specifically depicted and specified on maps, electronic shapefiles and block equivalency files submitted to the Louisiana Secretary of State, be and is hereby adopted and such plan shall be utilized for qualifying for elections in the Fall of 2023 and the regularly scheduled elections in the Fall of 2023 for Beauregard Parish, in accordance with Louisiana law.

B. The Beauregard Parish Police Jury shall be comprised of ten (10) members listed in Section 2.C utilizing the parish's current precincts and the precincts created by this ordinance in Section 1.

C1. District 1 shall consist of Precincts 1A, 9, 10 and 11

C2. District 2 shall consist of Precincts 1, 2, 3, 4, 5, 6, 7A and 7C

C3. District 3A shall consist of Precincts 25B, 26 and 28

C4. District 3B shall consist of Precincts 16A, 16B, 17, 17A, 18, 18A and 19

C5. District 3C shall consist of Precincts 11A, 13, 13A, 14, 27, 27A and 27D

C6. District 3D shall consist of Precincts 7, 25, 25A and 26A

C7. District 3E shall consist of Precincts 7B, 27B, 27C, 28A and 30

C8. District 4A shall consist of Precincts 11B, 12 and 12B

C9. District 4B shall consist of Precincts 12A, 12C, 14A, 15, 16 and 16C

C10. District 5 shall consist of Precincts 16D, 19C, 20, 21 and 22
