The existing longitudinal slopes on Texas Eastern Road, a Beauregard Parish Road at the UPPR crossing are too steep for low clearance trailers to cross without the possibility of hanging up. This project will correct the slopes leading to the RR Crossing by adding asphaltic concrete in layers. The final longitudinal slopes will allow safe passage for low clearance trailers. There will be no work on U.S. Hwy 190 travel lane or shoulders. This project will not affect existing drainage in any way.
